### 6 ACMOC Directors report

The secretary read report provided by Earl Shanks.

This report endeavours to bring Chapter 19 members of the Club a snapshot of ACMOC's current position and plans moving forward.

#### Finance:

President Kurt Bangert has taken it upon himself to sort out the Clubs finances and take control of the bank accounts. Ex treasurer Sue Westwood has, through a series of personal misfortunes (motor bike accident and others) been unable to assist in a smooth transition of Club financial business. Kurt now has control of the bank accounts and is able to issue cheques. The Club credit card is yet to be reissued.

The Club has four bank accounts, having funds of just over US\$300,000. This includes the Scholarship account which is currently at US\$37,500. The terms of access to the Scholarship account have been reviewed and are now open to a wider section of the ACMOC family.

With these efforts, the club should be able to produce financial statements and position in the near future for 2025.

### Elections:

At this month's Director's meeting it was agreed that an AGM was well overdue and that positions on the Board would be open for nominations. As per the constitution, thirty day written notice must be given to all members before an AGM. This will probably be in the form of a mail out to all members, as well as a notification in the magazine. It is envisaged that the voting will be concluded by December 10.

## Yellow Power:

General consensus is that the world is too small for two Caterpillar antique clubs. Also, we believe that Caterpillar Inc would prefer to deal with the one entity.

There have been a couple of meetings between ACMOC and YP regarding a merger. YP proposed that they rejoin or reform with ACMOC. But they had conditions. They proposed a name change for the Club. I disagreed with that, as it would mean that all the Australian Clubs would have to re-write their constitution, probably at a financial cost as well. Also, ACMOC, the name, has been around for years. They also wanted two seats on the board. YP has about 160 members, so less members than Chapter 19. About one half of YP members are also ACMOC members. So YP consists of around 7% of ACMOC members. I think the tail is trying to wag the dog.

Personally, if they want to rejoin with ACMOC, they can come on board like any other member. No favours.

#### The Website:

This month's Directors meeting discussed the website and its failings. Briefly, because I am no computer guru, and have little understanding of its technicalities, I understand that the original website (which seemed okay to me) was replaced due to its security system being out of date.

Currently, ADCO are working to resolve the many website issues. It seems that one of our problems stems from the AIT which is breaking when under load. That is, I am led to believe, is when the site askes too many questions of the ZOHO system at once. I'll be happy when the membership function is fixed.

#### In general:

It looks like Chapter 9 (Colorado and Wyoming) may reform. Aaron Fehr, a recent board member is working on this. Was great to see a contingent of Chapter 19 guys at the NHMA rally in the weekend. Most Chapter 18 people decided not to front, citing transport costs as the issue. We have Kingaroy in September.

Maning of the booth at Elkader seems to be low on volunteers within the USA, and the Club is grateful for the offer of help from the Chapter 19 visitors.

# 8 Finance report

The treasurer (GS) presented the finance report as at 30<sup>th</sup> June 2025. (Copy attached) and thanked William Adams accountants who had assisted in preparation of the financial reports. Please note that the accounts are not independently audited, as we are not required to under CAV due to our low turnover.

# 9 Membership report

G.Slocombe gave account of membership status, reminding those present that the definition of Chapter 19 member is someone that is a financial member of ACMOC and has confirmed they wish to be associated with, and receive correspondence from Chapter 19. ACMOC financial members can be members of more than one Chapter.

Chapter 19 currently has 172 members that are financial with ACMOC (up from 156 same time last year), of which the breakdown is as follows.

- Vic = 117 (+17)
- NSW = 20 (-1)
- SA = 18
- Tas = 9 (+1)
- ACT = 1
- QLD = 4
- UK 1

There were 6 Chapter memberships that expired as at 30 JUNE 2025 year that have not been renewed. This is better than last year multiple reminders have been sent.

Globally the Club has recovered and grown back up to around 2300 members I have been told.

Due to challenges with data migration from the older systems to the new ZOHO system, the Club apologises for any issues experience by members associated with online renewals. Much of this was found to be caused by members with multiple accounts, and they are working through this progressively. For instance, if you signed up one year as auto renewal online, then the next via the Chapter for 12 months you have two separate accounts. To help clean this up the Club has granted administration access to Chapter 19 and Chapter 30 secretaires to the ZOHO system which enables us to make changes and view the main data.

### 10 Merchandise

A massive year for the Chapter as previously reported, generated from three key areas;

- 1. We were the only Chapter to work exclusively with Caterpillar to develop, gain approval and purchase exclusive ACMOC/100-year merchandise lines. Even the Club did not take advantage of this opportunity under our TML agreement. These jackets, polos and caps generated \$22,660 in sales, including the presales.
- 2. We leveraged our TML to also procure other licensed 100-year merchandise such as the pen, mug, commemorative coin, pin, sticker set and other caps. These items contributed \$4,002 in sales.
- 3. We purchased wholesale the 1:50 and 1:16 scale TWENTY models from Diecast Masters, and D6XE centenary models, which contributed \$11,740 in sales.

Additionally, we invested in high end CCM models for serious collectors and continued to ensure we had a good supply of kid's toys.

We have now exhausted the last of the Rohan Skennar "Caterpillar Dozers" picture books, and I have reconfirmed these are no longer in print. These alone generated \$2,010 of sales in the current FY.

A new agreement was reached late in 2024 with a different calendar supplier to provide a licensed Cat Historical Machinery calendar. This is not the one we have previously ordered from the USA, as that is no longer available, but this new format is a great item too and was well received. Despite not being available for Christmas we still sold 51 units for a total of \$1275 of sales and wholesaled at cost another 30 units for Chapter 18. Best of all under the new arrangement we get them printed here in Australia which reduces the price and gives better availability so we will have them before the holiday season this year. This is another example of a service previously provided by the Club, now only offered by Chapter 19 – hence we sold and shipped calendars to the UK & USA.

Speaking of printing, we also had the Tractor and Grader serial number books reprinted with a company in Geelong, this has dramatically reduced the cost to produce these, eliminated shipping from the USA and made the price much more acceptable and popular at \$20 for members. As we speak, I have a quote from this same printer to reproduce the yellow magazine binders as we have had several requests for these.

As you may be aware we have been working for many years to do a deal with the Club in the USA to purchase their remaining merchandise inventory, and finally we were

10 cont.	able to get this shipped in three crates in June thanks to Rob Fern. The committee have catalogued the inventory, which includes various terracers, with some 2T and 7U models, including the limited edition military 2T models, and we plan to make an offer to buy these from the Club and make them available for members to purchase, possibly at LGSPA.	
	William Adams continues to support the Chapter with donations of regular caps, kids caps and bucket hats which are always popular.	
	We have deliberately kept stock levels up at \$27,642 to make sure we can meet demand at LG and Tassie rallies, with a view to running this down into next year.	
	For these last two rallies we will also have limited edition ACMOC/100-year stubble holders printed with "LAKE GOLDSMITH RALLY 2025 and TASMANIA RALLY 2025" and I am looking at something similar for the last of the 100-year caps too.	
	The secretary expressed gratitude to the committee for the purchase of an iPad for use as a point-of-sale terminal and all assistance provided at rallies in the merchandise tent especially Suzanna and Marie.	
11	Replica Parts	
	New items including brass decompression and priming cocks, larger crank handles to suit TWENTY-FIVE and TWENTY- EIGHT models have been added that's to Mike Myer. Additionally, we tracked down the original suppliers to the Club for the radiator pressed tin model, and vertical & horizontal CATERPILLAR name plates and these are	

new items in stock.

Daryl Robins is currently in Thailand where he will arrange another batch of gaskets for stock.

### Treasurer's report

Caterpillar's centennial year 2024/25 promised to be something special, both in terms of celebrating the history, but also in capitalising on the increased member and public presence, and sales though our merchandise store. Chapter 19 single handedly produced licensed 100-year merchandise, when the Club did not and this has proved both popular locally and abroad with multiple shipments to the UK and USA. The profitability of this was also underpinned by generous support from Caterpillar of Australia and William Adams as part of an agreed 12 month package the committee was able to negotiate that saw Chapter 19 act as their key partner at number of events. Something no other Chapter in Australia or globally was able to achieve – so we should be rightly proud. This support included the donation of some of the merchandise rather than direct sponsorship to help manage cashflow and improve profitability, which was critical in the first part of the year. In fact, we also secured a temporary loan of \$5000 to secure significant merchandise in advance of the first rallies in March.

Revenue of \$74,950.61 was up dramatically by \$34,901.43 (+87%) from last year, almost exclusively due to the extraordinary increase in merchandise sales.

Apart from the exclusive range of ACMOC licensed 100-year merchandise, we also secured items from the approved Cat 100-year range, including the Twenty scale models and we ended up carrying more line items than even the dealer! This was complemented with other Cat approved items and a real focus on kids toys to attract impulse buys. This was a lot of work but resulted in a significant increase of merchandise sales of \$61,442.78 up \$43,792.78 (+248%) on prior year reflecting the hard work and dedication to both develop, stock and then attend rallies with the merchandise tent and sell it, along with pre-sales which worked well.

Replica parts revenue was up slightly to \$8,025.00 (+5%) and continues to be a staple for the Chapter, and pleasing Mike Meyer and Daryl Robins are replenishing and increasing our offering, while the Chapter has also secured new items for stock from the USA as well.

The focus now needs to be to run down some of our overall merchandise stock, with the remaining two major 100-year rallies in November 2025.

I'm pleased to report the Chapter made an overall profit for the year of \$24,041.32 up 92% from last year's \$12,479.68 which was also a strong result, with both of these positioning the Chapter to consider new special projects into the future and fund the upcoming rallies.

When considering revenue activities of the Chapter, merchandise sales generated \$25,102.04 @ 40.9% gross profit, which is a 5% improvement on prior year. Replica parts generating \$2,584.36 @ 32.2% gross profit also up year on year. The above excluding the impact of merchant fees (Square Credit Card and PayPal).

Trading expenses were well managed, and we fully recovered direct costs associated with managing membership payments of behalf of the Club and surprisingly activity was up, despite the new online payment system with many members joining through the Chapter initiated 12-month payment service. A small profit of \$162 was generated due to positive exchange rate variance on memberships. Postage expenses were also fully recovered this year.

This year I deliberately delayed collecting the 2025/26 NHMA insurance dues into July, so that we would not have to carry this revenue over into the new financial year, with payment due in July, this makes for a much cleaner set of books and worked well. A total of 46 members took up this offer in 2024/25 financial year. This is done on a cost recovery basis and no profit is realised on providing this service to members.

As at June 30, 2025 we had unrestricted cash funds of \$32,787.053 available, but are budgeting on costs associated with the two November rallies to be between \$15,000 - \$20,000. Regardless the Chapter in a very healthy financial state.
